Requirements The applicant must:

- Be an AOCMF member
- Be an active AOCMF faculty member, preferably holding a position at a university or academic institution
- Be highly motivated to contribute to build and maintain educational programs
- Have national and regional networks and strong interpersonal relationships
- Be able and willing to work in an ecumenical, constructive and inclusive way with surgeons of different surgical backgrounds, including but not limited to Oral & Maxillofacial Surgeons, Plastic Surgeons, Otolaryngologists, Head & Neck Surgeons, Ophthalmology and Oculoplastic Surgeons, and Neurosurgeons
- Be willing and prepared to travel regionally (no exclusions)
- Be a good/clear communicator, good listener, possess the ability to work in multi-cultural environments
- Possess a good command of the English language
- Be prepared to commit adequate time (eg, one day per month) to AOCMF / AO Foundation affairs

In addition, he/she:

- Should have international experience (eg, fellowship, faculty, or research travel)
- Should be a recognized member or officer on key national, regional, or international CMF associations
- Should be recognized as excellent educator
- Should hold/has held an AOCMF faculty or chairman position
- Should have relevant research experience
- Should have a good scientific reputation regionally, supported by high quality academic publications, books, etc.
